- B. The authorized place of use is at temporary sites, in areas not under exclusive Federal jurisdiction, throughout Texas. The licensee is authorized to use radioactive material at a temporary site up to 90 days in any twelvemonth period.
- 10. This license is issued in accordance with Title 25 Texas Administrative Code section(s):

- 15. The licensee is authorized to redistribute sealed sources and devices made by other manufacturers and registered in accordance with 25 TAC §289.252(v) or equivalent NRC or Agreement state rule.
- 16. The licensee is authorized to perform radiation survey instrument calibrations. The calibrations shall be performed in accordance with procedures described in application dated July 29, 2020.
- 17. The licensee shall maintain the financial assurance Surety Bond for \$113,000.00 current and in good standing.
- 18. Except as specifically provided otherwise by this license, the licensee shall possess and use the radioactive material authorized by this license in accordance with statements, representations, and procedures contained in the following:

Application dated July 29, 2020, and Electronic mail dated November 10, 2020, and January 28, 2021.

Title 25 TAC §289 shall prevail over statements contained in the above documents unless such statements are more restrictive than the regulations.
